For clinicians, consultants, and coaches, the subject of ethics is too often addressed in an oversimplified, legalistic, cover-your-bases way that primarily involves an orientation to the relevant professional written codes and the consequences of violating them. However, the dilemma of ethics is the endless potential individual interpretation and application to each situation, often necessarily undertaken without the benefit of consultation or collaboration.

This live online workshop takes a step beyond the basics to explore the relationship between these codes, the underlying individual and cultural values that shape individuals, and the real-life contradictions and complexities that produce ethical dilemmas. Participants will be encouraged to present their cases and share the issues they face in their own practices.

Benefits

Participants will:

- Explore issues with ethical implications in their own practice areas and caseloads.
- Develop awareness of the relationship between their personal needs, individual practice values, and professional responsibilities.
- Clarify their personal approach to ethical dilemmas.
- Understand the consequences of their choices.
- Develop a plan that includes supervision, feedback, and a network of support to gain perspective when approaching ethical dilemmas.
